**ENTRY CERTIFICATION, RELEASE AND INDEMNITY**

The undersigned hereby certifies that I have read, understand and will abide by all the rules and regulations in the current State Fair of Texas Online Premium List. I further certify that I have not administered to this entry, nor has it received to the best of our knowledge, any substance in any manner not approved by the FDA and/or USDA for use on livestock for slaughter and/or breeding. I understand and acknowledge that this entry will be tested under these Entry Certification, Release and Indemnity guidelines and the State Fair of Texas Online Premium List, and I acknowledge that this entry will be disqualified for any violation of such guidelines, rules and/or regulations. I also certify that, to the best of my knowledge, while under my ownership, possession, or direct control, the entry has not been fed any feed containing mammalian protein (i.e. ruminant derived meat or bone meal) as required in 21CFR 589.2000.

**Veterinarians/Medication:** animals under the care of a licensed veterinarian and/or taking any type of performance enhancing or other unapproved medications to include, but not limited to steroids, diuretics, anti-inflammatories, tranquilizers and painkillers, are ineligible for competition. Exhibitors with questions regarding medications and/or eligibility should consult with the Official SFT Veterinarian prior to competition. Unapproved means not approved by the Food and Drug Administration (FDA) and/or the U.S. Department of Agriculture (USDA) for slaughter animals including animals that may be destined for human consumption. The use of a FDA approved drug in an unapproved species will constitute unapproved drug use.

**Approved Drug Use:** If an animal has been administered a drug that is FDA approved for their particular species, sufficient time must have passed so that the animal does not test positive for that drug at check-in. All animals must be free and clear of all drug and chemical residues at the time of weigh-in. Please note that elimination time (the time it takes for no drug residue to be found in the system) is generally longer than the labeled FDA withdrawal time for most approved drugs.

The Official Show Veterinarian is available through SFT Livestock Management. Exhibitors must contact their Superintendent or the Livestock Office before the veterinarian is contacted. All veterinarian fees are the responsibility of the exhibitor. Any animal requiring emergency treatment from the Official Show Veterinarian during the show, MUST meet the requirements listed above.

I, the undersigned, hereby consent and agree that the market and/or breeding animal(s) described on this entry application may, at the discretion of the State Fair of Texas Livestock management, be tested, evaluated and/or analyzed for: (i) the improper use or administration of substances not approved by the FDA and/or USDA; and/or (ii) any method of altering or tampering with the natural conformation of any part of the animal's body. Improper usage or tampering will result in the disqualification of the animal entry along with exhibitor sanctions as established in the State Fair of Texas Livestock Premium List. All entry applications MUST be signed by the exhibitor and parent or guardian if the exhibitor is less than 18 years of age. Incomplete signatures constitute NO ENTRY.

In consideration for the State Fair of Texas allowing the undersigned to participate in the livestock shows, I, the undersigned, indemnify and hold State Fair of Texas, its officers, directors and employees, the City of Dallas, and the Park and Recreation Board of the City of Dallas, harmless from and against any and all claims, losses, demands, obligations, causes of action and lawsuits (collectively "Claims") and all damages, liabilities (including strict liability), fines, penalties, judgments, costs (including settlement costs), and expenses associated therewith (including the payment of reasonable attorney's fees and disbursements)(collectively "Damages"), to the extent Claims and Damages arise out of: (1) the failure of the undersigned to comply with the certifications, terms and conditions of this Entry Form and the State Fair of Texas Online Premium List; (2) the failure of the undersigned to comply with any applicable federal, state or local regulations or laws; (3) the services performed or actions taken by the undersigned; (4) the negligent, grossly negligent, fraudulent or intentional acts or omissions of the undersigned; or (5) any acts caused by the undersigned's animals.

I, the undersigned, have read and voluntarily sign this release and waiver of liability and indemnity agreement, and further agree that no oral representations, statements or inducements apart from the above written agreement have been made.
